

Most Recent Victories

In March 2017, King and Murray PLLC obtained a complete victory in an arbitration hearing in West Virginia where claimants were seeking over \$450,000 in damages in a Telephone Consumer Protection Act (“TCPA”) case. The claimants were awarded \$0, and the business client of King and Murray received an award for 100% of its claimed damages on its counterclaims. Total victory! Given the prevalence of mobile devices and businesses needing to contact consumers on their own turf, *i.e.*, via telephone calls and/or text messages, it is more important than ever that businesses understand the ground rules; specifically, the TCPA.
